The declaration, together with the written statements, must be filed with the Secretary of State no later than 5:00 p.m. of the 78th day before election day. The declaration, together with the written statements, may not be filed earlier than the 30<sup>th</sup> day before this date.

<sup>1</sup> All oaths, affidavits, or affirmations made within this State may be administered and a certificate of the fact given by a judge, clerk, or commissioner of any court of record, a notary public, a justice of the peace, and the Secretary of State of Texas. See Chapter 602 of the Texas Government Code for the complete list of persons authorized to administer oaths.
