# DPS Voter Registration Application Process



We offer the following methods for customer to complete a voter registration application. (EC 20.062, 20.064)

- In person in a driver license office since 1/92
- Online through the Texas by Texas (TxT) account since 9/20
- By telephone through Texas.gov since 9/20
- By mail for a change of address since 5/22

Mail renewals are still accompanied by the VR-64 application. There are plans to add the voter registration questions to the mail renewal form. (EC 20.063)

#### **In Person Application**

#### REQUIRED INFORMATION FROM ALL APPLICANTS



Are you a citizen of the United States? If no, go to question 3.

If you are a U.S. citizen, would you like to register to vote? If registered, would you like to update your voter information?

I understand that giving false information to procure a voter registration is perjury, and a crime under state and federal law. Conviction of this crime may result in imprisonment up to one year in jail, a fine up to \$4,000, or both. PLEASE READ ALL THREE STATEMENTS TO AFFIRM BEFORE SIGNING.

I am a resident of the county provided above, and a U.S. citizen; I have not been finally convicted of a felony, or if a felon, I have completed all of my punishment including any term of incarceration, parole, supervision, period of probation, or I have been pardoned; And I have not been determined by a final judgment of a court exercising probate jurisdiction to be totally mentally incapacitated or partially mentally incapacitated without the right to vote.

By providing my electronic signature, I understand the personal information on my application form and my electronic signature will be used for submitting my voter's registration application to the Texas Secretary of State's office. Wanting to register to vote, I authorize the Department of Public Safety to transfer this

information to the Texas Secretary of State.

The attestation is the same for the DPS application as for the SOS mail application, except that the DPS application includes approval to send the electronic signature to SOS. (EC 20.066)



The driver license system, known as DLS, allows a voter registration application only if a person is:

- A U.S. Citizen
- At least 17 years and 10 months old

These criteria are programmed into the system and cannot be bypassed. If the person selects "yes" but they are not eligible, DLS will only continue if "no" is selected.

If eligible and the person says "yes", the questions for election judge and type of application are requested by the employee and entered in DLS. This is the same eligibility process for online transactions.

# Voter Registration Information File

8/7/2025

A daily file is sent Monday - Friday and includes every voter registration occurring the prior business day. These include in person, online, telephone or mail address changes and record updates. (EC 20.065)

#### File fields are:

- Full and AKA Names,
- DOB,
- SSN,
- Sex,
- Voter status and Election Judge,
- Card Type and Number,
- Application Date,
- Physical and Mailing Address, and
- Signature Image.

# By the Numbers

The voter registration application online and telephone began on September 20, 2020. Since that time, we have seen an increase in the overall number of applications completed.

- FY 20, there were 1.4M in office, no online
- FY 21, there were 1.4M in office and 1.2M online
- FY 24, there were 1.6M in office and 1.3M online

Telephone and mail address change transactions are less than 20,000 annually.









2D barcodes can contain cardholder data in a standardized, machine-readable format

#### **Tactile Text**

Expiration Date is laser engraved in the card to provide a raised effect that you can feel as you rub your finger across the surface of the card.
