### Extension of Comment Period

The Office of the Attorney General (OAG) published notice of its intention to amend §53.2 and §53.16 in Title 1 of the Texas Administrative Code (TAC), relating to the form of records and submission and approval of public finance transcripts. The proposed rules were published in the December 12, 2025, issue of the *Texas Register* (50 TexReg 7963) with a comment period ending January 11, 2026. **The comment period for the proposed rules will be extended through February 10, 2026.**

### Notice of Settlement of a Recovery Action for Response Costs

The State of Texas gives notice of the following proposed resolution of an action to recover costs under the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA). Before the State may enter into a voluntary settlement agreement, pursuant to section 7.110 of the Texas Water Code, the State shall permit the public to comment in writing. The Attorney General will consider any written comments and may withdraw or withhold consent to the proposed agreement if the comments disclose facts or considerations indicating that consent is inappropriate, improper, inadequate, or inconsistent with the requirements of the law.

Case Title: *State of Texas v. Hydro Resources Corporation*; Case No. 5:25-cv-00236-H, in the United States District Court for the Northern District of Texas.

Background: On October 31, 2025, the State of Texas filed a Complaint against Hydro Resources Corporation (Hydro) for cost recovery under Section 107 of CERCLA, 42 U.S.C. § 9607, related to response and cleanup actions taken at a site in Anton, Texas. The Complaint alleges that Hydro is liable under CERCLA for costs incurred by the Texas Commission on Environmental Quality (TCEQ) in connection with response actions taken at the site in Anton, which was formerly operated by Bulldog Services, LLC. Specifically, Hydro stored six drums containing cyanide waste on the site, at least some of which were uncovered, posing a threat to public health and the environment. TCEQ spent \$32,850.35 to remove the drums from the site and arrange for their transportation and disposal.

Proposed Settlement: Hydro will pay \$26,000 to the State under the proposed Consent Decree. Of this total, \$25,000 is designated as re-

imbursement for the response costs, and \$1,000 is designated as the State's reasonable attorney's fees.

For a complete description of the settlement, the Complaint and proposed Consent Decree should be reviewed in its entirety. ### Notice of Update to the Texas Private Real Property Rights Preservation Act Guidelines

The Office of the Attorney General intends to revise the Texas Private Real Property Rights Preservation Act Guidelines (the Guidelines) found on the Office's website and is publishing the proposed changes in the *Texas Register* for 30 days so that the Office may accept public comment regarding the proposed settlement.

Under section 2007.041 of the Texas Government Code, the Attorney General must (1) prepare guidelines to assist governmental entities in identifying and evaluating governmental actions described in section 2007.003(a)(1)-(3) that may result in a taking, (2) file the guidelines with the Secretary of State for publication in the *Texas Register* in the manner prescribed by chapter 2002 of the Texas Government Code, and (3) review the guidelines at least annually and revise the guidelines as necessary to ensure consistency with the actions of the Texas Legislature and the decisions of the United States Supreme Court and the Texas Supreme Court. The Office of the Attorney General thus intends to revise and update the Guidelines as indicated herein and will accept public comment on the proposed changes.

In 2024, the Texas Supreme Court issued its decision in *Texas Department of Transportation v. Self*, 690 S.W.3d 12 (Tex. 2024), which clarified the elements of a taking and specified the requisite intent for a taking. Specifically, the Court stated that, for a taking to occur, certain acts must result "in taking, damaging, or destroying the property for, or applying it to . . . public use." *Id.* at 26. Further, the Court stated that a governmental entity's mistaken belief regarding the legal right to take a specific action does not, in and of itself, exempt that action as a taking: "[T]he government must pay compensation when it intentionally takes private property for public use--even if the government mistakenly believes that it has a legal right to do so apart from its power of eminent domain." *Id.* at 29.

The Office of the Attorney General proposes to update the Guidelines to reflect the decision in *Self* in two ways. The first proposed update would specify that taking may result from actions that, in addition to

taking property, result in the damage or destruction of property. The second update spells out the clarification in *Self* that a mistaken belief does not exempt an action from being a taking. No other actions or decisions of the Texas Legislature, United States Supreme Court, or Texas Supreme Court warrant any update to the Guidelines.

### **Certification of the Average Closing Price of Gas and Oil - November 2025**

The Comptroller of Public Accounts, administering agency for the collection of the Oil Production Tax, has determined, as required by Tax Code, §202.058, that the average taxable price of oil for reporting period November 2025 is \$37.58 per barrel for the three-month period beginning on August 1, 2025, and ending October 31, 2025. Therefore, pursuant to Tax Code, §202.058, oil produced during the month of November 2025, from a qualified low-producing oil lease, is not eligible for credit on the oil production tax imposed by Tax Code, Chapter 202. Due to a lack of consumer price index (CPI) data for October 2025, the Comptroller utilized the CPI data from September 2025 when calculating the 2005 price for the month of October 2025.

The Comptroller of Public Accounts, administering agency for the collection of the Natural Gas Production Tax, has determined, as required by Tax Code, §201.059, that the average taxable price of gas for reporting period November 2025 is \$1.22 per mcf for the three-month period beginning on August 1, 2025, and ending October 31, 2025. Therefore, pursuant to Tax Code, §201.059, gas produced during the month of November 2025, from a qualified low-producing well, is eligible for a 100% credit on the natural gas production tax imposed by Tax Code, Chapter 201. Due to a lack of consumer price index (CPI) data for October 2025, the Comptroller utilized the CPI data from September 2025 when calculating the 2005 price for the month of October 2025.

The Comptroller of Public Accounts, administering agency for the collection of the Franchise Tax, has determined, as required by Tax Code, §171.1011(s), that the average closing price of West Texas Intermediate crude oil for the month of November 2025 is \$59.48 per barrel. Therefore, pursuant to Tax Code, §171.1011(r), a taxable entity shall not exclude total revenue received from oil produced during the month of November 2025, from a qualified low-producing oil well.

The Comptroller of Public Accounts, administering agency for the collection of the Franchise Tax, has determined, as required by Tax Code, §171.1011(s), that the average closing price of gas for the month of November 2025 is \$4.64 per MMBtu. Therefore, pursuant to Tax Code, §171.1011(r), a taxable entity shall exclude total revenue received from gas produced during the month of November 2025, from a qualified low-producing gas well.

### **Agreed Orders**

The Texas Commission on Environmental Quality (TCEQ, agency, or commission) staff is providing an opportunity for written public comment on the listed Agreed Orders (AOs) in accordance with Texas Water Code (TWC), §7.075. TWC, §7.075 requires that before the commission may approve the AOs, the commission shall allow the public an opportunity to submit written comments on the proposed AOs. TWC, §7.075 requires that notice of the proposed orders and the opportunity to comment must be published in the *Texas Register* no later than the 30th day before the date on which the public comment period closes, which in this case is **February 24, 2026**. TWC, §7.075 also requires that the commission promptly consider any written comments received and that the commission may withdraw or withhold approval of an AO if a comment discloses facts or considerations that indicate that consent is inappropriate, improper, inadequate, or inconsistent with the requirements of the statutes and rules within the commission's jurisdiction or the commission's orders and permits issued in accordance with the commission's regulatory authority. The Texas Health and Human Services Commission (HHSC) is submitting a request to the Centers for Medicare & Medicaid Services (CMS) to renew the Non-Emergency Medical Transportation (NEMT) Statewide Fee-for-Service (FFS) Selective Contracting waiver authorized under §1915(b)(4) of the Social Security Act (the Act). HHSC provides NEMT services under the Texas Medicaid state plan, and CMS approved HHSC's waiver through May 31, 2026, for the NEMT FFS Selective Contracting program which limits choice of demand response transportation service (DRTS) providers. The proposed effective date for this renewal is June 1, 2026.

HHSC intends to continue to selectively contract with providers for the provision of NEMT FFS DRTS to the Medicaid FFS population in the State of Texas. DRTS is considered transportation that involves using contractor dispatched vehicles in response to on-demand requests for individual or shared one-way trips. The utilization of selective contracts affords HHSC the ability to continue the uninterrupted delivery of DRTS to Medicaid-eligible clients.

Services for clients in FFS will remain unchanged. HHSC will ensure DRTS are available statewide, are similar in scope and duration for all eligible clients, consistent with the best interest of clients, appropriate to available services, geographic locations, and limitation of clients, reasonably prompt, and administratively efficient.

This renewal specifies HHSC has management and operational oversight for the statewide FFS DRTS. The changes in this renewal include the following: this renewal identifies individuals receiving retroactive eligibility as an excluded population only during the period of retroactive enrollment; this renewal updates the approximate number of Medicaid FFS clients that are eligible for NEMT services and the approximate total of clients that use FFS NEMT services. HHSC also updated the number of participants where appropriate. This renewal includes an updated provider capacity analysis spreadsheet. Outdated language was also removed or edited. For example, language regarding the planned termination of medical transportation organizations (MTOs) was updated as the terminations were completed during the implemen-

tation of the initial waiver. This renewal updates the monitoring frequency of providers from monthly to quarterly. HHSC also updated the projected waiver expenditures for the renewal period.

#### Appendix J

HHSC revised the unduplicated number of participants (Factor C) and PIT calculations for the overall projected cost of waiver services (Factor D) and the overall projected cost of other Medicaid services furnished to waiver participants (D Prime (D')) for waiver years (WYs) three through five. HHSC also updated the average length of stay as a result of the updated Factor C and PIT calculations.

The DBMD waiver program provides essential home and community-based services and supports to individuals with legal blindness, deafness, or a condition that leads to deafblindness, and at least one additional disability that limits functional abilities and who live in their own homes or in the home of another person, such as a family member or in

a small group home setting. Services and supports are intended to enhance quality of life, functional independence, health and welfare, and to supplement, rather than replace, existing informal or formal supports and resources. Services in the DBMD waiver program are case management, residential habilitation, respite (in-home and out of home), supported employment, prescribed medications, financial management services, support consultation, adaptive aids and medical supplies, assisted living, audiology services, behavioral support, chore services, dental treatment, dietary services, employment assistance, intervener, minor home modifications, nursing, occupational therapy services, orientation and mobility, physical therapy services, speech, hearing and language therapy, transition assistance services, employment readiness and individualized skills and socialization.

The Texas Higher Education Coordinating Board (Coordinating Board) staff is providing an opportunity for written public comment on the revision of the Field of Study Curriculum (FOSC) for Computer Science.

Texas Education Code (TEC) Chapter 61, Subchapter S, establishes policies to facilitate statewide transfer, including the FOSC. Institutions must accept partially or fully completed Field of Study Curricula for academic credit toward the degree program in which the transfer student enrolls (TEC §61.823). The Coordinating Board has promulgated rules related to transfer policy in 19 Texas Administrative Code

(TAC) Chapter 1, Subchapter V, and Chapter 4, Subchapter B. Posting requirements may be found in 19 TAC §§4.33(f) and 1.239(b).

The Computer Science Discipline-Specific Subcommittee met on November 3, 2025, and November 4, 2025, to consider and make recommendations to the Texas Transfer Advisory Committee regarding the FOSC for this discipline using the alternative FOSC framework as outlined in 19 TAC §4.32(d). On December 8, 2025, the Texas Transfer Advisory Committee adopted the subcommittee recommendations for the designated Texas Core Curriculum courses and the Discipline Foundation Courses and recommended their submission to the Commissioner of Higher Education for final approval.

The recommended courses are as follows:

Designated Core Courses in the Field of Study:

MATH 2413: Calculus I (4 SCH)

Discipline Foundation Courses:

COSC 1336/1436: Programming Fundamentals I (3 or 4 SCH)

COSC 1337/1437: Programming Fundamentals II (3 or 4 SCH)

COSC 2336/2436: Programming Fundamentals III (3 or 4 SCH)

COSC 2325/2425: Computer Organization (3 or 4 SCH)

MATH 2305: Discrete Mathematics (3 SCH)

MATH 2414: Calculus II (4 SCH)

In addition to these courses, each general academic institution will have the opportunity to submit to the Coordinating Board up to twelve (12) semester credit hours of Directed Electives selected by the institution from the Academic Course Guide Manual. The complete FOSC will consist of the Designated Core Courses and Discipline Foundation Courses listed above, as well as Directed Electives selected by the relevant general academic institutions in compliance with the transfer rules in TAC Chapter 4, Subchapter B, including §§4.23(4), 4.32(b)(3), and 4.33.

General academic institutions will be required to transfer these courses and apply them for academic credit towards degree programs with majors in the following CIP Code:

A prize winner in the "LUCKY 7s TRIPLER" Scratch Ticket Game is determined once the latex on the Scratch Ticket is scratched off to expose forty-eight (48) Play Symbols. BONUS: If a player reveals 2 matching Play Symbols in the BONUS, the player wins the prize. LUCKY 7s TRIPLER: If a player matches any of the YOUR NUMBERS Play Symbols to any of the WINNING NUMBERS Play Symbols, the player wins the prize for that number. If a player reveals a "7" Play Symbol, the player wins the prize for that symbol instantly. If a player reveals a "777" Play Symbol, the player wins TRIPLE the prize for that symbol. No portion of the Display Printing nor any extraneous matter whatsoever shall be usable or playable as a part of the Scratch Ticket.

#### 2.1 Scratch Ticket Validation Requirements.

A. To be a valid Scratch Ticket, all of the following requirements must be met:

1. Exactly forty-eight (48) Play Symbols must appear under the Latex Overprint on the front portion of the Scratch Ticket;
2. Each of the Play Symbols must have a Play Symbol Caption underneath, unless specified, and each Play Symbol must agree with its Play Symbol Caption;
3. Each of the Play Symbols must be present in its entirety and be fully legible;
4. Each of the Play Symbols must be printed in black ink except for dual image games;
5. The Scratch Ticket shall be intact;

6. The Serial Number and Game-Pack-Ticket Number must be present in their entirety and be fully legible;

7. The Serial Number must correspond, using the Texas Lottery's codes, to the Play Symbols on the Scratch Ticket;

8. The Scratch Ticket must not have a hole punched through it, be mutilated, altered, unreadable, reconstituted or tampered with in any manner;

9. The Scratch Ticket must not be counterfeit in whole or in part;

10. The Scratch Ticket must have been issued by the Texas Lottery in an authorized manner;

11. The Scratch Ticket must not have been stolen, nor appear on any list of omitted Scratch Tickets or non-activated Scratch Tickets on file at the Texas Lottery;

12. The Play Symbols, Serial Number and Game-Pack-Ticket Number must be right side up and not reversed in any manner;

13. The Scratch Ticket must be complete and not miscut, and have exactly forty-eight (48) Play Symbols under the Latex Overprint on the front portion of the Scratch Ticket, exactly one Serial Number and exactly one Game-Pack-Ticket Number on the Scratch Ticket;

14. The Serial Number of an apparent winning Scratch Ticket shall correspond with the Texas Lottery's Serial Numbers for winning Scratch Tickets, and a Scratch Ticket with that Serial Number shall not have been paid previously;

15. The Scratch Ticket must not be blank or partially blank, misregistered, defective or printed or produced in error;

16. Each of the forty-eight (48) Play Symbols must be exactly one of those described in Section 1.2.C of these Game Procedures;

17. Each of the forty-eight (48) Play Symbols on the Scratch Ticket must be printed in the Symbol font and must correspond precisely to the artwork on file at the Texas Lottery; the Scratch Ticket Serial Numbers must be printed in the Serial font and must correspond precisely to the artwork on file at the Texas Lottery; and the Game-Pack-Ticket Number must be printed in the Game-Pack-Ticket Number font and must correspond precisely to the artwork on file at the Texas Lottery;

18. The Display Printing on the Scratch Ticket must be regular in every respect and correspond precisely to the artwork on file at the Texas Lottery; and

19. The Scratch Ticket must have been received by the Texas Lottery by applicable deadlines.

B. The Scratch Ticket must pass all additional validation tests provided for in these Game Procedures, the Texas Lottery's Rules governing the award of prizes of the amount to be validated, and any confidential validation and security tests of the Texas Lottery.

C. Any Scratch Ticket not passing all of the validation requirements is void and ineligible for any prize and shall not be paid. However, the Executive Director of the Texas Lottery ("Executive Director") may, solely at the Executive Director's discretion, refund the retail sales price of the Scratch Ticket. In the event a defective Scratch Ticket is purchased, the only responsibility or liability of the Texas Lottery shall be to replace the defective Scratch Ticket with another unplayed Scratch Ticket in that Scratch Ticket Game (or a Scratch Ticket of equivalent sales price from any other current Texas Lottery Scratch Ticket Game) or refund the retail sales price of the Scratch Ticket, solely at the Executive Director's discretion.

## 2.2 Programmed Game Parameters.

A. GENERAL: Consecutive Non-Winning Tickets within a Pack will not have matching patterns, in the same order, of either Play Symbols or Prize Symbols.

B. GENERAL: A Ticket can win as indicated by the prize structure.

C. GENERAL: A Ticket can win up to twenty-one (21) times.

D. GENERAL: On winning and Non-Winning Tickets, the top cash prizes of \$1,000 and \$100,000 will each appear at least one (1) time, except on Tickets winning twenty-one (21) times, with respect to other parameters, play action or prize structure.

E. GENERAL: The "7" (WIN\$) or "777" (TRP) Play Symbols will never appear in the BONUS play area.

F. BONUS: A Ticket can win up to one (1) time in the BONUS play area.

G. BONUS: The BONUS play area will consist of two (2) Play Symbols and one (1) Prize Symbol.

H. BONUS: Winning Tickets will have two (2) matching Play Symbols in the BONUS play area.

I. BONUS: A non-winning BONUS play area will have two (2) different Play Symbols.

J. LUCKY 7s TRIPLER: A Ticket can win up to twenty (20) times in the main play area.

K. LUCKY 7s TRIPLER: All non-winning YOUR NUMBERS Play Symbols will be different.

L. LUCKY 7s TRIPLER: Non-winning Prize Symbols will never match a winning Prize Symbol on a Ticket.

M. LUCKY 7s TRIPLER: Tickets winning more than one (1) time will use as many WINNING NUMBERS Play Symbols as possible to create matches, unless restricted by other parameters, play action or prize structure.

N. LUCKY 7s TRIPLER: No matching WINNING NUMBERS Play Symbols will appear on a Ticket.

O. LUCKY 7s TRIPLER: All YOUR NUMBERS Play Symbols will never equal the corresponding Prize Symbol (i.e., 05 and \$5, 10 and \$10, 15 and \$15, 20 and \$20 and 30 and \$30).

P. LUCKY 7s TRIPLER: On all Tickets, a Prize Symbol will not appear more than three (3) times, except as required by the prize structure to create multiple wins.

Q. LUCKY 7s TRIPLER: On Non-Winning Tickets, a WINNING NUMBERS Play Symbol will never match a YOUR NUMBERS Play Symbol.

R. LUCKY 7s TRIPLER: The "7" (WIN\$) Play Symbol will never appear on the same Ticket as the "777" (TRP) Play Symbol.

S. LUCKY 7s TRIPLER: The "7" (WIN\$) Play Symbol will win the prize for that Play Symbol.

T. LUCKY 7s TRIPLER: The "7" (WIN\$) Play Symbol will never appear more than one (1) time on a Ticket.

U. LUCKY 7s TRIPLER: The "7" (WIN\$) Play Symbol will never appear on a Non-Winning Ticket.

V. LUCKY 7s TRIPLER: The "7" (WIN\$) Play Symbol will never appear as a WINNING NUMBERS Play Symbol.

W. LUCKY 7s TRIPLER: The "777" (TRP) Play Symbol will never appear more than one (1) time on a Ticket.

X. LUCKY 7s TRIPLER: The "777" (TRP) Play Symbol will win TRIPLE the prize for that Play Symbol and will win as per the prize structure.

Y. LUCKY 7s TRIPLER: The "777" (TRP) Play Symbol will never appear on a Non-Winning Ticket.

Z. LUCKY 7s TRIPLER: The "777" (TRP) Play Symbol will never appear as a WINNING NUMBERS Play Symbol.

### 2.3 Procedure for Claiming Prizes.

A. To claim a "LUCKY 7s TRIPLER" Scratch Ticket Game prize of \$5.00, \$10.00, \$15.00, \$20.00, \$30.00, \$50.00, \$100, \$250 or \$500, a claimant shall sign the back of the Scratch Ticket in the space designated on the Scratch Ticket and may present the winning Scratch Ticket to any Texas Lottery Retailer. The Texas Lottery Retailer shall verify the claim and, if valid, and upon presentation of proper identification, if appropriate, make payment of the amount due the claimant and physically void the Scratch Ticket; provided that the Texas Lottery Retailer may, but is not required, to pay a \$30.00, \$50.00, \$100, \$250 or \$500 Scratch Ticket Game. In the event the Texas Lottery Retailer cannot verify the claim, the Texas Lottery Retailer shall provide the claimant with a claim form and instruct the claimant on how to file a claim with the Texas Lottery. If the claim is validated by the Texas Lottery, a check shall be forwarded to the claimant in the amount due. In the event the claim is not validated, the claim shall be denied and the claimant shall be notified promptly. A claimant may also claim any of the above prizes under the procedure described in Section 2.3.B and Section 2.3.C of these Game Procedures.

B. To claim a "LUCKY 7s TRIPLER" Scratch Ticket Game prize of \$1,000 or \$100,000, the claimant must sign the winning Scratch Ticket and may present it at one of the Texas Lottery's Claim Centers. If the claim is validated by the Texas Lottery, payment will be made to the bearer of the validated winning Scratch Ticket for that prize upon presentation of proper identification. When paying a prize of \$600 or more, the Texas Lottery shall file the appropriate income reporting form with the Internal Revenue Service (IRS) and shall withhold federal income tax at a rate set by the IRS if required. In the event that the claim is not validated by the Texas Lottery, the claim shall be denied and the claimant shall be notified promptly.

C. As an alternative method of claiming a "LUCKY 7s TRIPLER" Scratch Ticket Game prize, the claimant may submit the signed winning Scratch Ticket and a thoroughly completed claim form via mail. If a prize value is \$1,000,000 or more, the claimant must also provide proof of Social Security number or Tax Payer Identification (for U.S. Citizens or Resident Aliens). Mail all to: Texas Lottery, P.O. Box 16600, Austin, Texas 78761-6600. The Texas Lottery is not responsible for Scratch Tickets lost in the mail. In the event that the claim is not validated by the Texas Lottery, the claim shall be denied and the claimant shall be notified promptly.

D. Prior to payment by the Texas Lottery of any prize, the Texas Lottery shall deduct the amount of a delinquent tax or other money from the winnings of a prize winner who has been finally determined to be:

1. delinquent in the payment of a tax or other money to a state agency and that delinquency is reported to the Comptroller under Government Code §403.055;
2. in default on a loan made under Chapter 52, Education Code;
3. in default on a loan guaranteed under Chapter 57, Education Code; or
4. delinquent in child support payments in the amount determined by a court or a Title IV-D agency under Chapter 231, Family Code.

E. If a person is indebted or owes delinquent taxes to the State, other than those specified in the preceding paragraph, the winnings of a person shall be withheld until the debt or taxes are paid.

2.4 Allowance for Delay of Payment. The Texas Lottery may delay payment of the prize pending a final determination by the Executive Director, under any of the following circumstances:

- A. if a dispute occurs, or it appears likely that a dispute may occur, regarding the prize;
- B. if there is any question regarding the identity of the claimant;
- C. if there is any question regarding the validity of the Scratch Ticket presented for payment; or
- D. if the claim is subject to any deduction from the payment otherwise due, as described in Section 2.3.D of these Game Procedures. No liability for interest for any delay shall accrue to the benefit of the claimant pending payment of the claim.

2.5 Payment of Prizes to Persons Under 18. If a person under the age of 18 years is entitled to a cash prize under \$600 from the "LUCKY 7s TRIPLER" Scratch Ticket Game, the Texas Lottery shall deliver to an adult member of the minor's family or the minor's guardian a check or warrant in the amount of the prize payable to the order of the minor.

2.6 If a person under the age of 18 years is entitled to a cash prize of \$600 or more from the "LUCKY 7s TRIPLER" Scratch Ticket Game, the Texas Lottery shall deposit the amount of the prize in a custodial bank account, with an adult member of the minor's family or the minor's guardian serving as custodian for the minor.

2.7 Scratch Ticket Claim Period. All Scratch Ticket prizes must be claimed within 180 days following the end of the Scratch Ticket Game or within the applicable time period for certain eligible military personnel as set forth in Texas Government Code §466.408. Any rights to a prize that is not claimed within that period, and in the manner specified in these Game Procedures and on the back of each Scratch Ticket, shall be forfeited.

2.8 Disclaimer. The number of prizes in a game is approximate based on the number of Scratch Tickets ordered. The number of actual prizes available in a game may vary based on number of Scratch Tickets manufactured, testing, distribution, sales and number of prizes claimed. A Scratch Ticket Game may continue to be sold even when all the top prizes have been claimed.

### 3.0 Scratch Ticket Ownership.

A. Until such time as a signature is placed upon the back portion of a Scratch Ticket in the space designated, a Scratch Ticket shall be owned by the physical possessor of said Scratch Ticket. When a signature is placed on the back of the Scratch Ticket in the space designated, the player whose signature appears in that area shall be the owner of the Scratch Ticket and shall be entitled to any prize attributable thereto. Notwithstanding any name or names submitted on a claim form, the Executive Director shall make payment to the player whose signature appears on the back of the Scratch Ticket in the space designated. If more than one name appears on the back of the Scratch Ticket, the Executive Director will require that one of those players whose name appears thereon be designated by such players to receive payment.

B. The Texas Lottery shall not be responsible for lost or stolen Scratch Tickets and shall not be required to pay on a lost or stolen Scratch Ticket.

4.0 Number and Value of Scratch Prizes. There will be approximately 5,040,000 Scratch Tickets in Scratch Ticket Game No. 2723. The approximate number and value of prizes in the game are as follows:
